

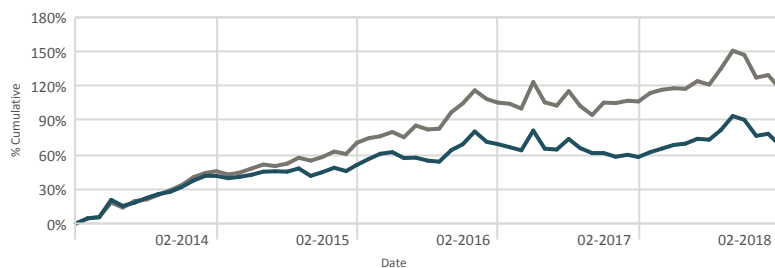
INVESTMENT OBJECTIVE

The portfolio objective is to secure high long-term capital growth.

INVESTMENT UNIVERSE

The BCI Best Blend Global Equity Fund is a multi-managed global equity portfolio investing across developed and emerging markets with the aim to generate high long term capital growth. The portfolio's exposure to assets outside of South Africa will be in excess of 80% of the portfolio's net asset value and the portfolio's exposure to equity securities will always exceed 80% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing instruments, equity securities, property securities, preference shares, convertible equities and non-equity securities as well as participatory interests. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include forward currency, interest rate and exchange rate swap transactions.

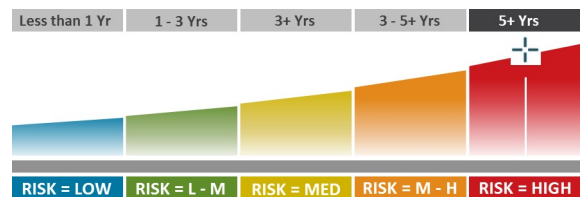

High Risk
