

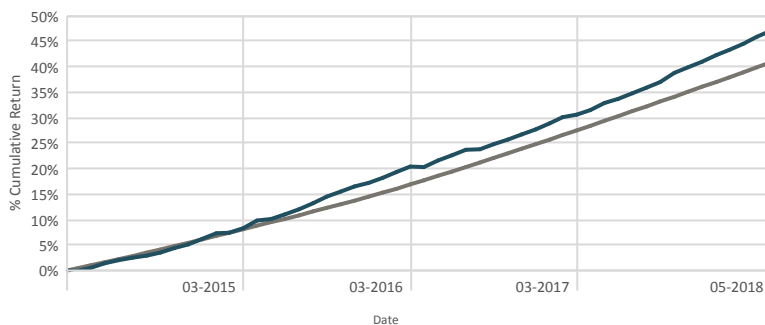
**+ INVESTMENT OBJECTIVE**

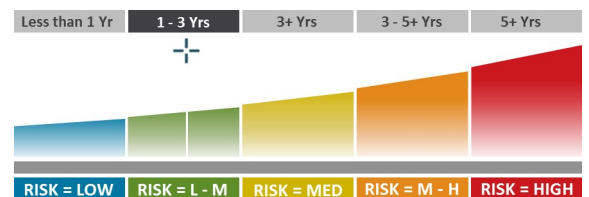

**Low - Medium Risk**
