

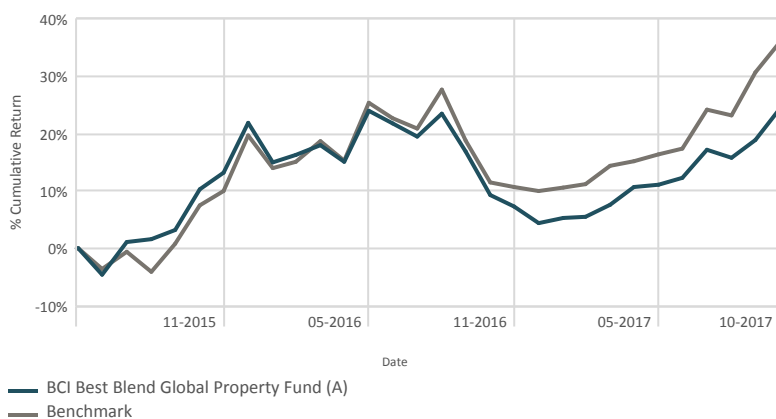
+ INVESTMENT OBJECTIVE

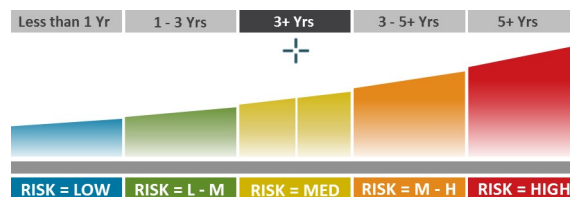
