

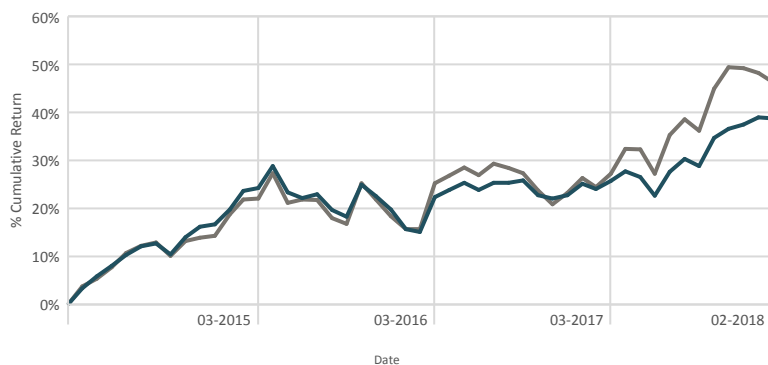
+ INVESTMENT OBJECTIVE

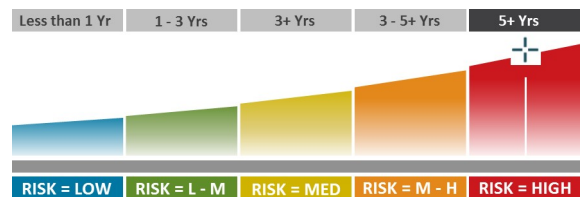

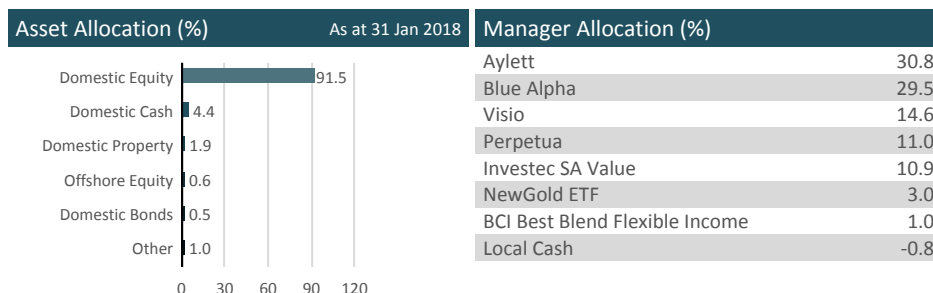


High Risk
