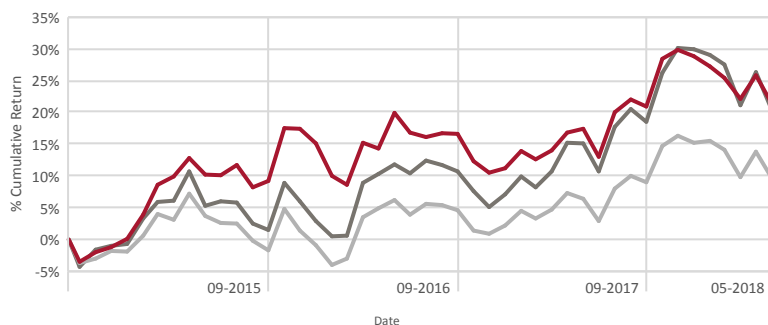

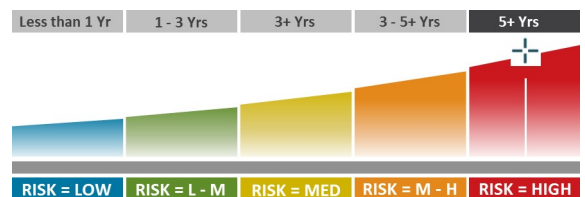

High Risk
