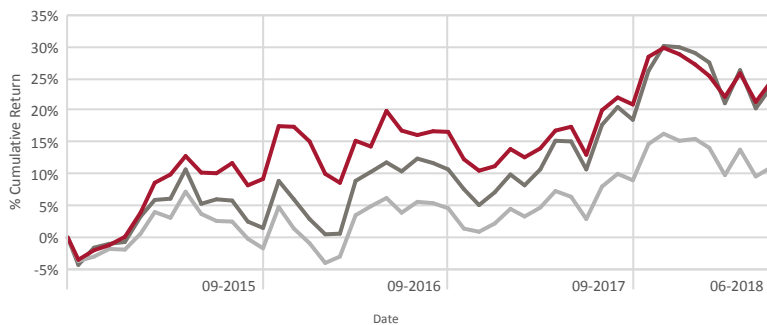

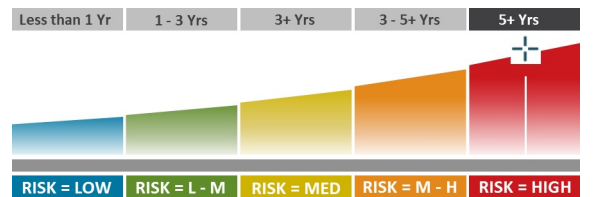

High Risk
