

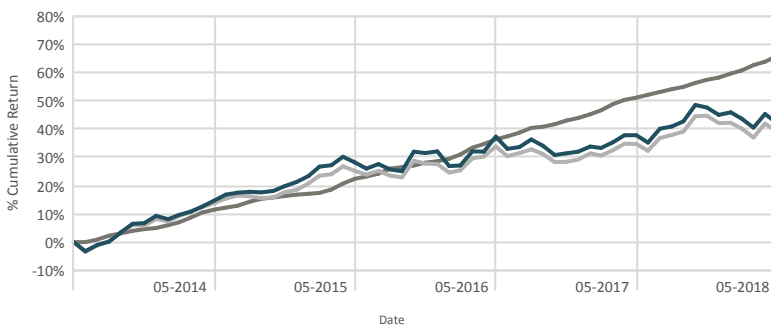
+ INVESTMENT OBJECTIVE

The objective of this portfolio is to provide the investor with a high long term total return.

+ INVESTMENT UNIVERSE

The Fund of Funds is a managed fund of funds. The primary investment objective of the portfolio is to optimise investment opportunities to generate capital growth and maximise total return for investors over the medium to long term. Over longer periods the portfolio attempts to produce meaningful inflation-beating returns. The portfolio will seek to follow an investment policy which will reflect a spread of investments aiming at income and capital growth normally associated with the investment structure of a retirement fund. The portfolio's equity exposure should, on average, vary between 0% and 75% of the portfolio's net asset value.

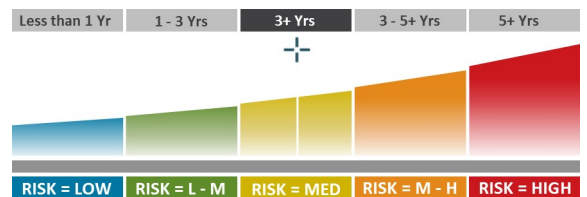

Medium Risk

- This portfolio has a balanced exposure to various asset classes. It has more equity exposure than a low risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a low risk portfolio, but less than a high-risk portfolio.
