Fund Objective

The ABSA Access BCI Passive Growth Fund provides investors access to market-related returns through the use of passive and smart-beta investment strategies by employing single and multi-asset class investment managers who pursue these strategies. The smart-beta strategies may include the following investment factors: market, defensive, quality, size and value, momentum and profitability, and will be used with the aim to deliver better risk adjusted long term total returns.

The funds aims to provide investors with capital growth over the long term and may exhibit high levels of return volatility and possible capital loss over the short term.

The portfolio is managed according to the guidelines as set out in Regulation 28 of the Pension Fund Act and is suitable for pension fund investment selection.

The composition of the portfolio shall reflect the investment structure of a retirement fund with a moderate risk profile therefore the portfolio's equity exposure will be limited to maximum 70% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities, convertible debentures and non-equity securities. The portfolio may from time to time invest in listed an unlisted financial instruments. The manager may include forward currency, interest rate and exchange rate swap transactions.

Fund Strategy

The fund will actively allocate between assets classes to achieve the objective based on thorough quantitative and qualitative analysis.

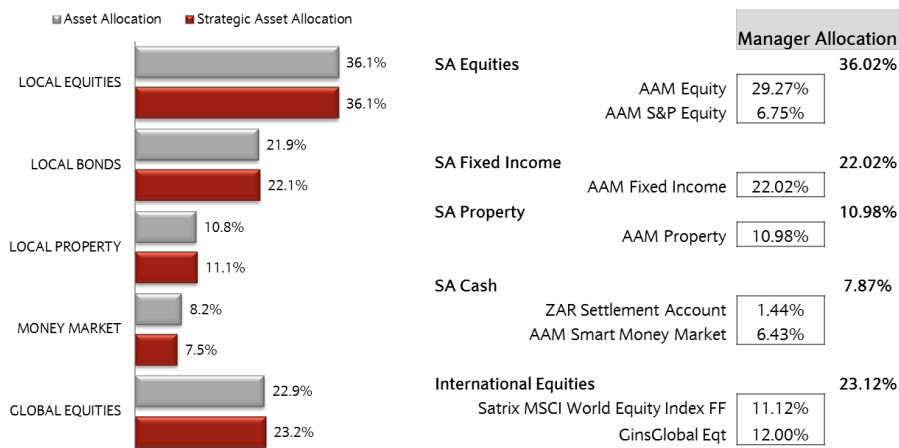

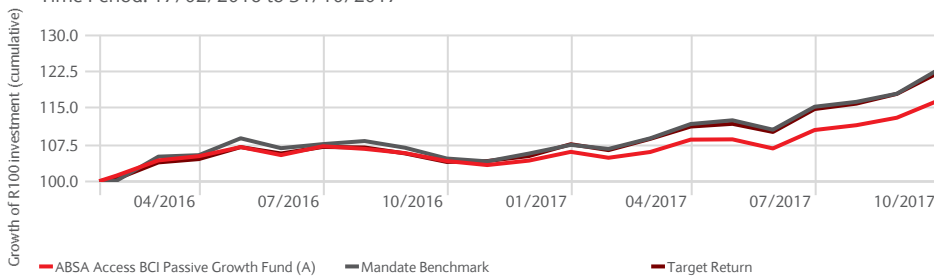
