INVESTMENT STRATEGY

The fund targets a return, net of fund management fees, of inflation plus three percent over a three year period whilst actively minimising the level of risk. To achieve this, a multi manager approach is used to benefit from a combination of fund managers that complement each other in their investment styles and processes. The fund is managed actively to enhance returns by allocating capital to asset classes based on valuations and long term potential growth. Risk is managed by diversifying the capital between different asset classes and fund managers. The fund will never have an equity exposure of more than 40%.

This portfolio has low or no equity exposure, resulting in far less volatility than more aggressive mandated portfolios and in turn the probability of a long-term capital loss is much less likely. 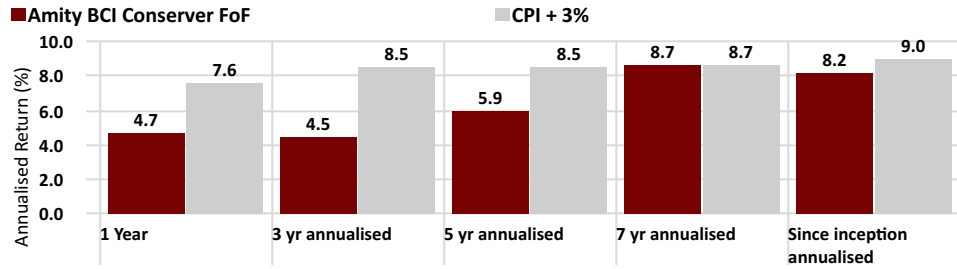

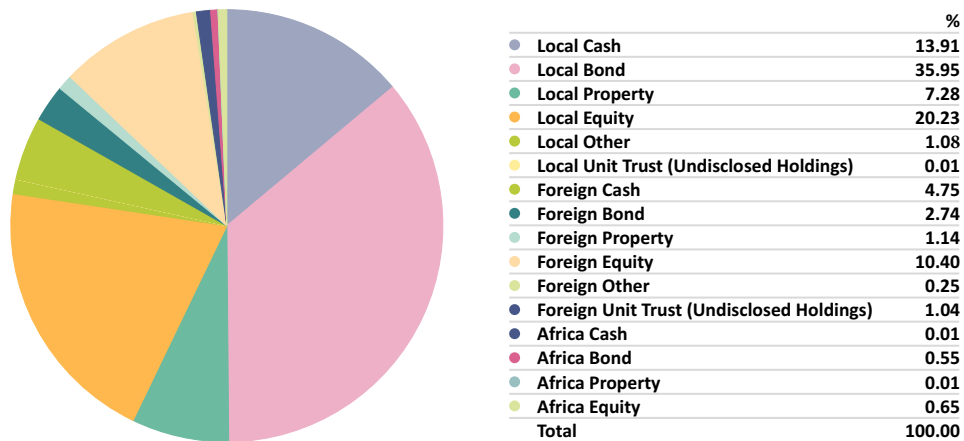

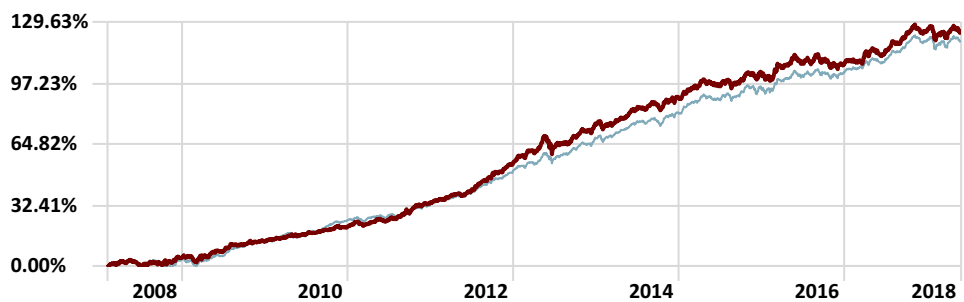
