

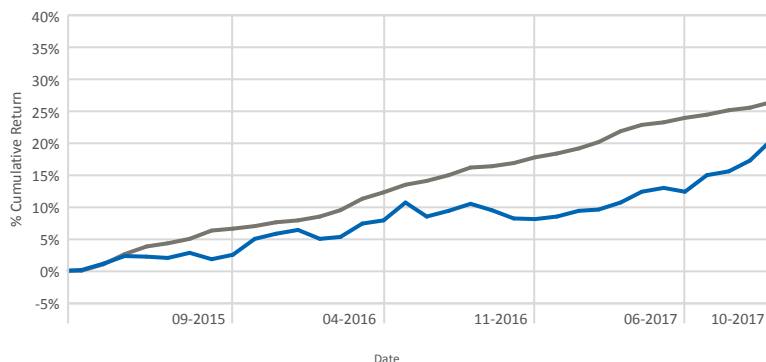
## INVESTMENT OBJECTIVE

The API BCI Stable Fund of Funds is a cautious risk profile portfolio with the objective of targeting a high level of income and relatively stable capital growth by maintaining investment exposures across various asset classes.

## INVESTMENT UNIVERSE

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value.

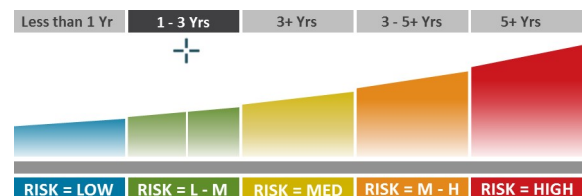
