

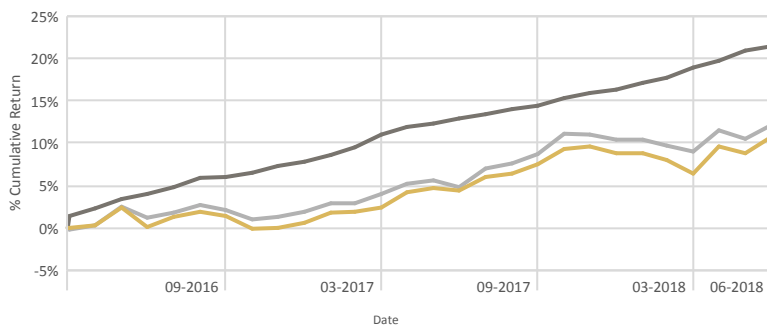
INVESTMENT OBJECTIVE

The Aureus Nobilis BCI Cautious Fund is a cautious risk profile that aims to provide investors with a high level of income and capital stability.

INVESTMENT UNIVERSE

To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, other interest bearing securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments.

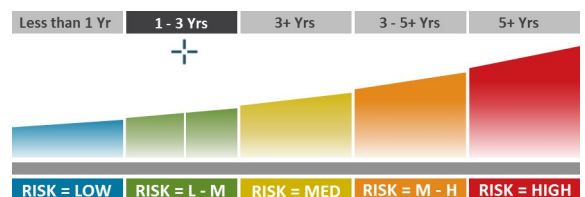

Low - Medium Risk
