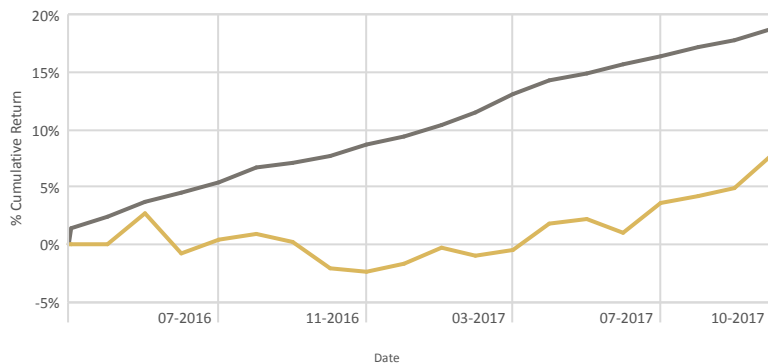
INVESTMENT OBJECTIVE

The Aureus Nobilis BCI Managed Fund is a moderate risk portfolio that aims to accumulate wealth for investors by delivering a high long term total return.

INVESTMENT UNIVERSE

The portfolio is managed in compliance with the prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. The portfolio's net equity exposure will range between 0% and 75% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, other interest bearing securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments.

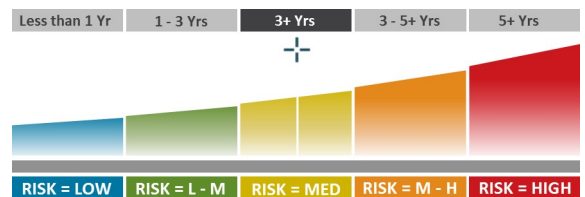

Medium Risk
