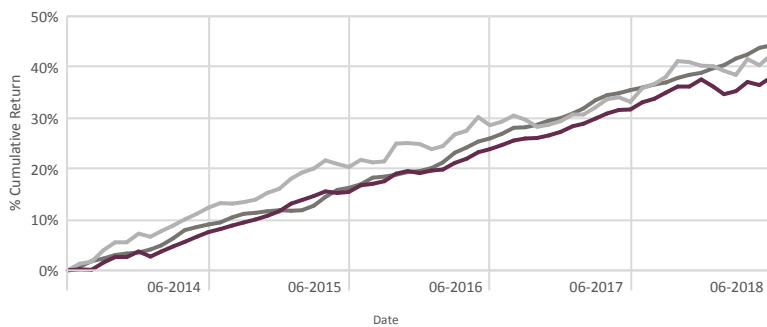
INVESTMENT OBJECTIVE

The primary objective is seeking positive returns more than inflation for all urban areas plus 2% per annum over 3-year rolling periods.

INVESTMENT UNIVERSE

The Stewart BCI Absolute Return Fund of Funds is a cautious fund of funds portfolio with a primary objective of seeking positive returns more than inflation for all urban areas plus 2% per annum over 3-year rolling periods. To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. The underlying portfolios may invest in, amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds and other interest bearing instruments and securities.

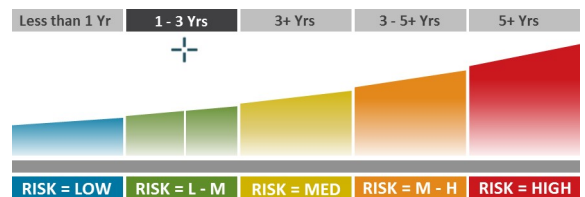

Low - Medium Risk
