

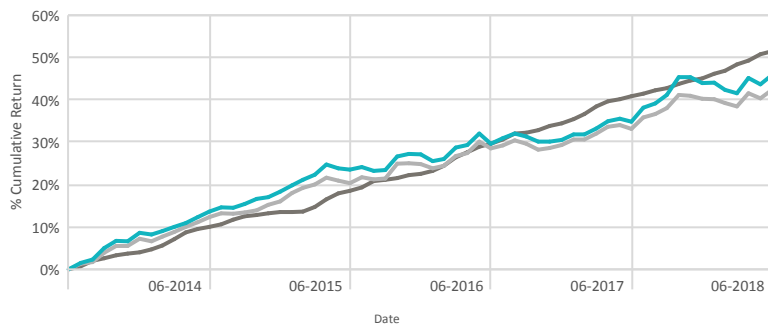
## INVESTMENT OBJECTIVE

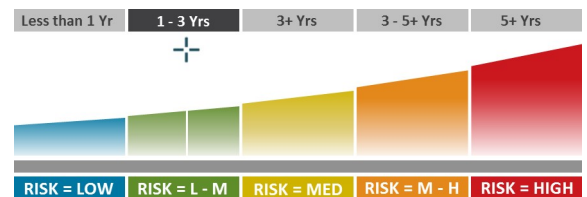
