



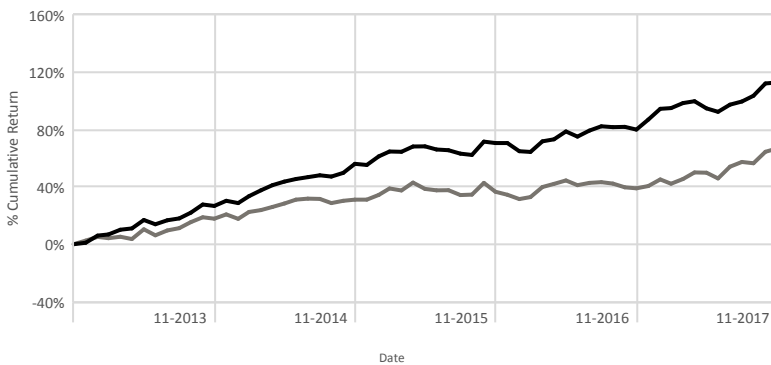
**+** INVESTMENT OBJECTIVE

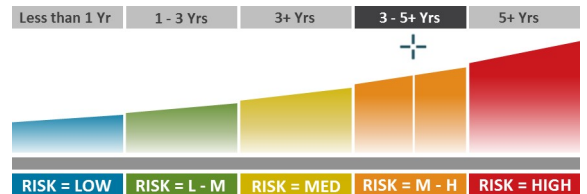

**Medium - High Risk**
