

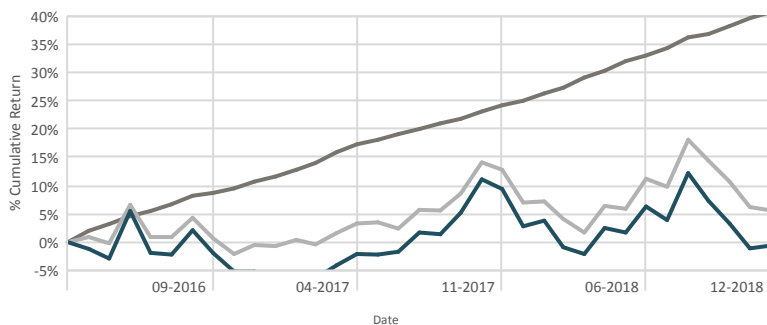
INVESTMENT OBJECTIVE

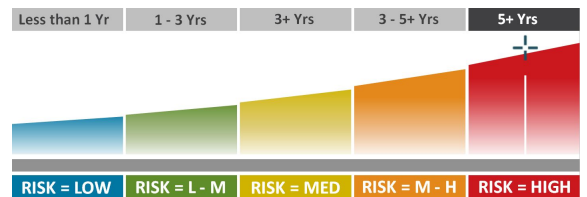

High Risk
