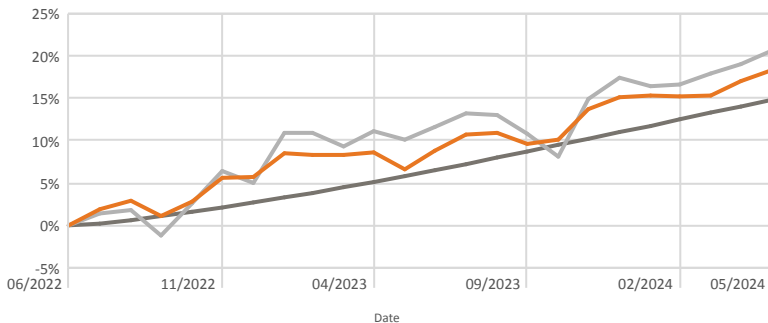
### INVESTMENT OBJECTIVE

The BCI SA Flexible Fund is a South African flexible mandate portfolio with the objective to deliver moderate income as well as long term capital growth.

### INVESTMENT POLICY

The manager will manage the portfolio's asset allocation actively. The investments normally to be included in the portfolio may invest in South African money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities, non-equity securities and assets in liquid form. The portfolio may invest in participatory interests or any other form of participation in portfolios of South African registered collective investment schemes or other similar collective investment schemes as the Act may allow from time to time. The portfolio may from time to time invest in listed and unlisted financial instruments.

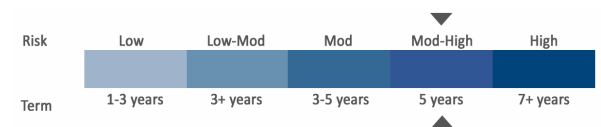

### Moderate - High Risk
