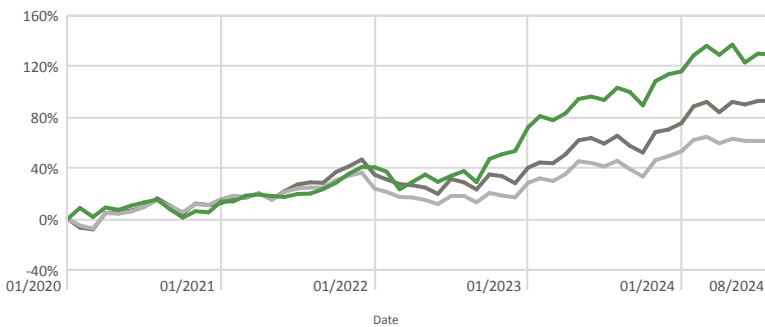
INVESTMENT OBJECTIVE

The BCI Ranmore Global Value Equity Feeder Fund aims to provide investors with a long-term capital growth.

INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Ranmore Global Equity Fund plc domiciled in Ireland. The portfolio is a global equity portfolio with a developed market bias and is managed with a value-based investment approach. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act. The Trustee shall ensure that the investment policy set out in this Supplemental Deed is carried out.

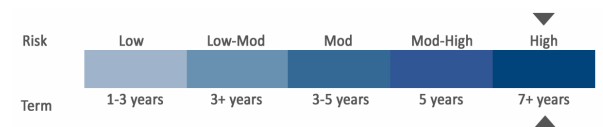
