INVESTMENT OBJECTIVE

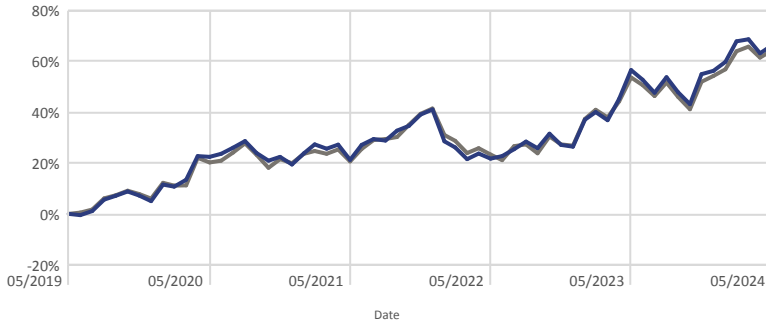
The aim is investing in a diversified range of global asset classes through an underlying feeder portfolio.

INVESTMENT POLICY

The BCI UBAM Multifunds Flexible Allocation Feeder Fund aims to capture investment opportunities by investing in a diversified range of global asset classes through an underlying feeder portfolio. The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the UBAM Multifunds Flexible Allocation, a sub-fund of UBAM, a variable investment company ("SICAV"), established under the laws of the Grand-Duchy of Luxembourg. The underlying portfolio invests in money market instruments, bonds as well as participatory interests of underlying portfolios of collective investment schemes or other similar schemes operated in territories with an equivalent regulatory supervision environment as the underlying portfolio.

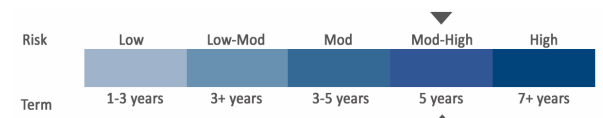

RISK PROFILE



Moderate - High Risk
