
INVESTMENT OBJECTIVE

The objective is to achieve a high level of sustainable income and stability of capital invested.

INVESTMENT POLICY

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa subject to a maximum equity of 10% of the portfolio's net asset value. Investments to be acquired may include equity securities, property securities, property related securities, interest bearing securities, non-equity securities, notes, money market instruments, preference shares and assets in liquid form. The portfolio may invest in participatory interests and other forms of participation in portfolios of collective investment scheme. The portfolio may from time to time invest in listed and unlisted financial instrument.


