INVESTMENT OBJECTIVE

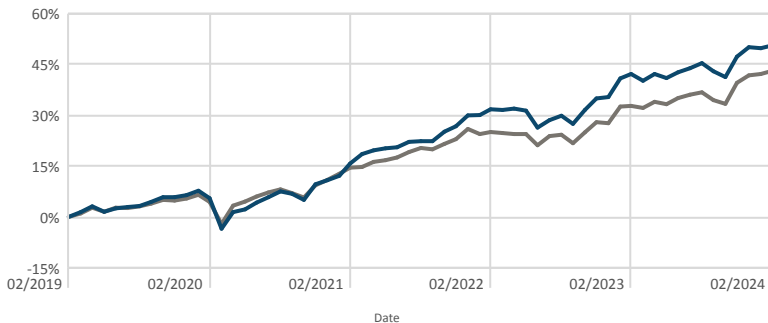
The 3B BCI Stable Fund of Funds is a low equity prudential fund of funds. The primary investment objective of the portfolio is to provide the investor with a moderate to high level of income and stable long term capital growth.

INVESTMENT POLICY

Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes. Investing in amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities. The portfolio's equity exposure may be as high as 40% of the portfolio's net asset value.

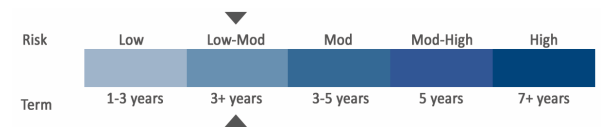

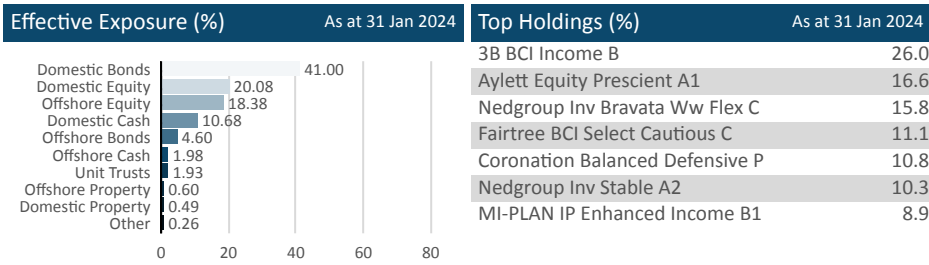
Low - Moderate Risk
