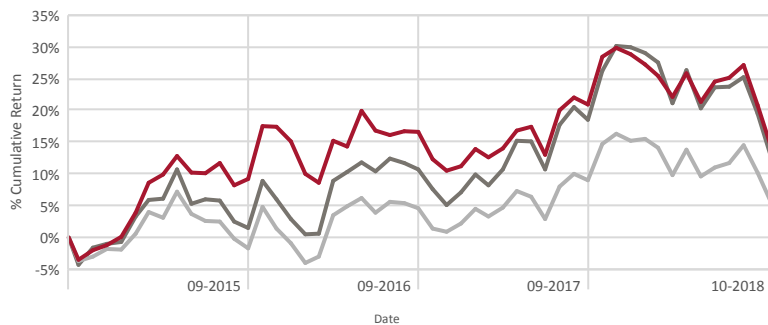

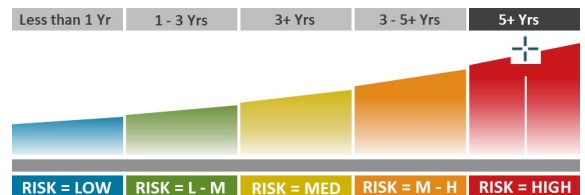

High Risk
