

**INVESTMENT OBJECTIVE**

The 3B BCI Flexible Balanced Fund aims to maximise long term real returns whilst being cognisant of protecting capital over the medium to long term.

**INVESTMENT POLICY**

The portfolio shall have maximum flexibility in terms of asset allocation and shall not be precluded from continually varying its exposure to the various asset classes, subject to the portfolio's maximum equity and offshore exposure be limited to 80% and 90% of its net asset value respectively. The investments to be included in the portfolio may comprise a combination of local and global assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

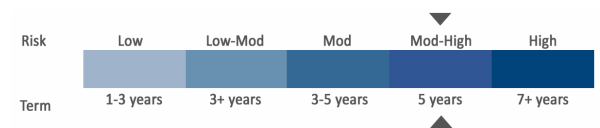

**Moderate - High Risk**
