

INVESTMENT OBJECTIVE

The 3B BCI Flexible Defensive Fund aims to protect and grow capital in real terms, with a low probability of capital losses in nominal terms over any rolling one-year period.

INVESTMENT POLICY

The portfolio shall have maximum flexibility in terms of asset allocation and shall not be precluded from continually varying its exposure to the various asset classes, subject to the portfolio's maximum equity and offshore exposure be limited to 40% and 50% of its net asset value respectively. The investments normally to be included in the portfolio may comprise a combination of local and global assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

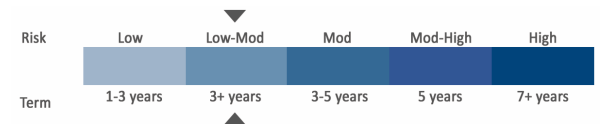
