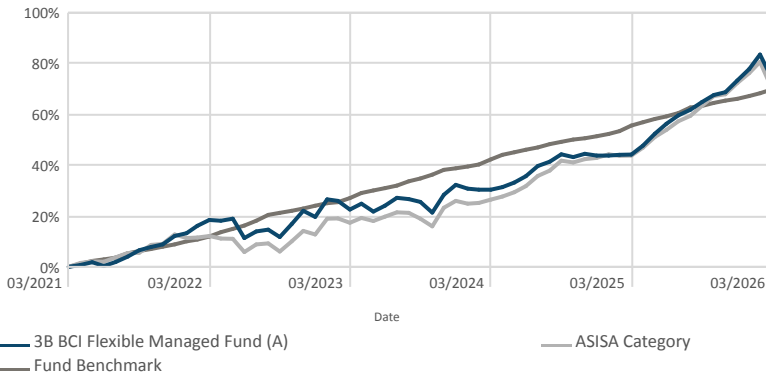
The 3B BCI Flexible Managed Fund is a flexible portfolio that aims to provide investors with high long term total returns.

INVESTMENT POLICY

The portfolio may invest in global and local equity securities, government -, corporate- and inflation linked bonds, debentures, non-equity securities, property shares, property related securities, preference shares, money market instruments and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes or other similar schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

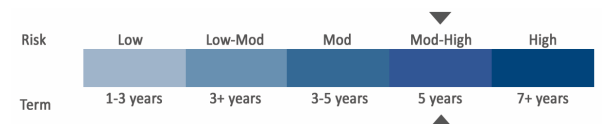

Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
