

INVESTMENT OBJECTIVE

The AG Capital BCI Enhanced Income Fund aims to provide investors with enhanced income returns in excess of money market funds, whilst minimising volatility in the short term.

INVESTMENT POLICY

To provide relative capital stability, the weighted average modified duration of the underlying assets is limited to a maximum of two years. The portfolio is managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes, registered in South Africa and other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective.

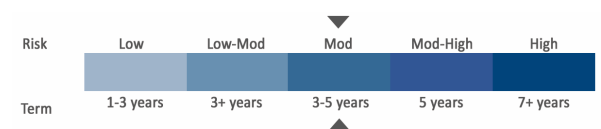
