

INVESTMENT OBJECTIVE

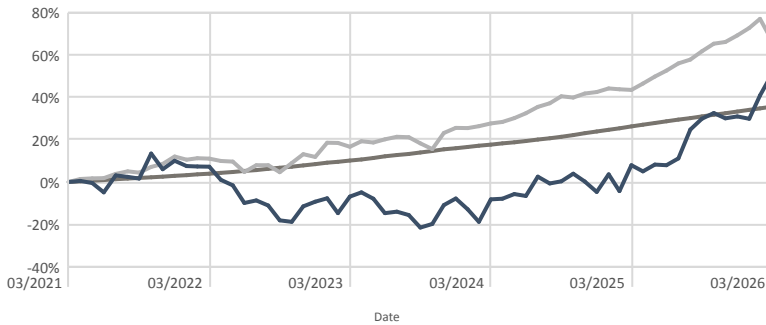
The AG Capital BCI Value Flexible Fund aims to provide investors with medium to long-term capital growth by applying a value-based long-term investment strategy.

INVESTMENT POLICY

In order to achieve its objective, the investments to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

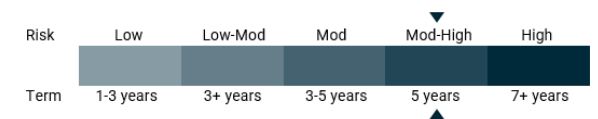

Moderate - High Risk
