

INVESTMENT OBJECTIVE

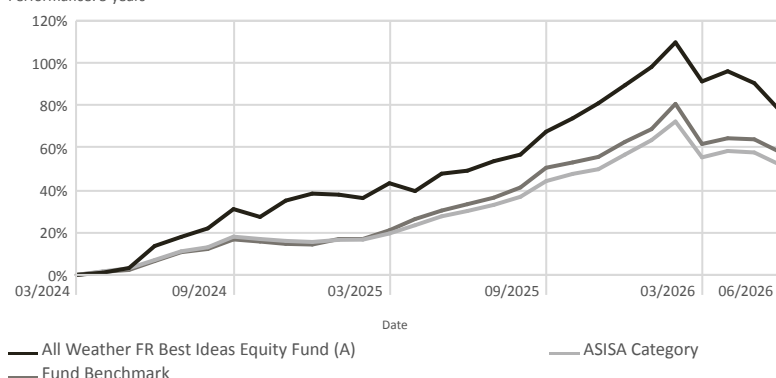
The All Weather FR Best Ideas Equity Fund is a concentrated equity portfolio that aims to achieve high long term capital growth by investing in up to 25 listed companies, both local and offshore, that reflect the manager's best investment ideas.

INVESTMENT POLICY

The portfolio's minimum equity exposure will be 80% of the portfolio's total assets. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, interest bearing instruments, non-equity securities, notes, property securities and preference shares. Participation in portfolios outside South Africa is only allowed if the regulatory environment in that territory meets standards that the manager and trustee consider equivalent to South Africa's investor protection requirements. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act.

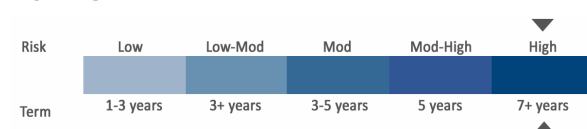
