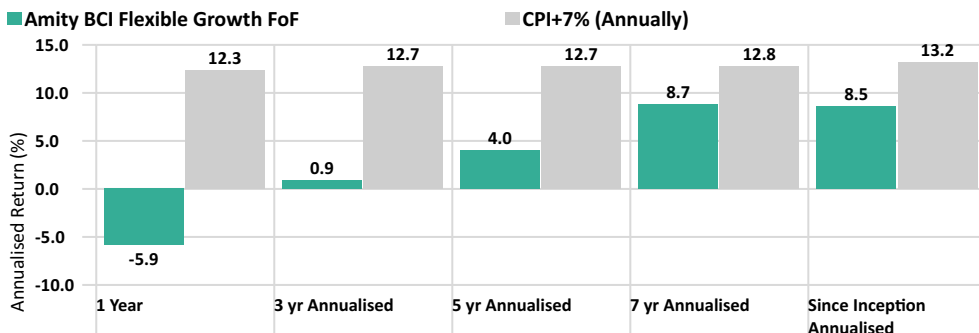

Highest 1 year rolling return **32.48%**

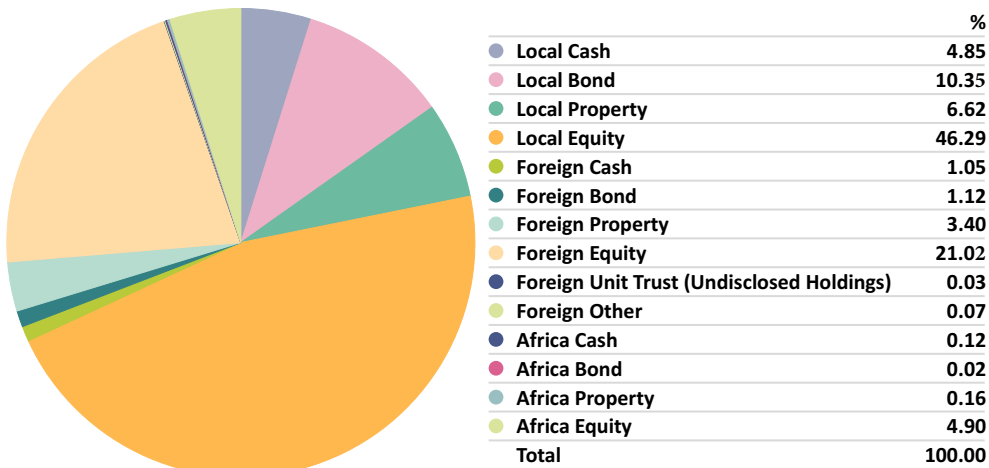

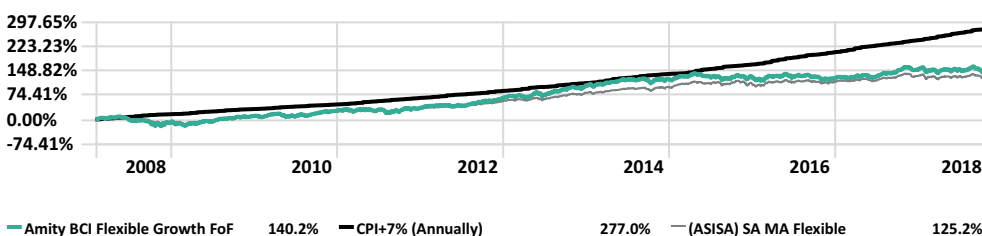
