AMPERSAND BCI BOND FUND (B)

INVESTMENT OBJECTIVE

The Ampersand BCI Bond Fund aims to generate returns similar or above the FTSE JSE All Bond Index ("ALBI") at similar or lower risk measured over 1 year rolling periods.

INVESTMENT POLICY

The portfolio will offer potential for capital growth as well as a regular level of income. No duration constraints will apply, with the underlying investments being managed by combining passive and actively managed strategies and will change over time to reflect the managers assessment of interest rate cycles. The portfolio invests predominantly in domestic bonds. The investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

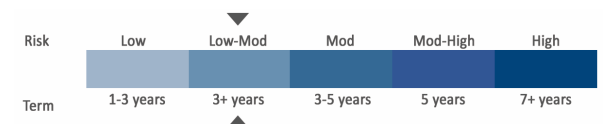

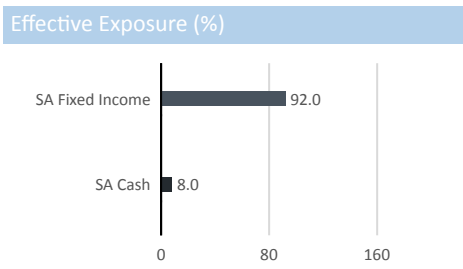
RISK PROFILE
