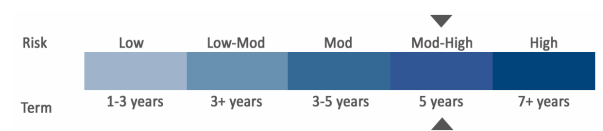

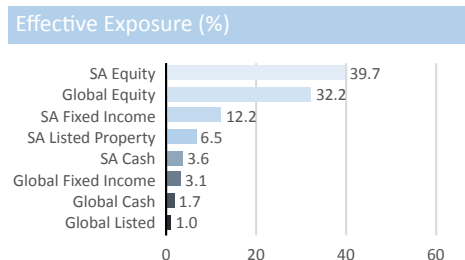
Moderate - High Risk
