

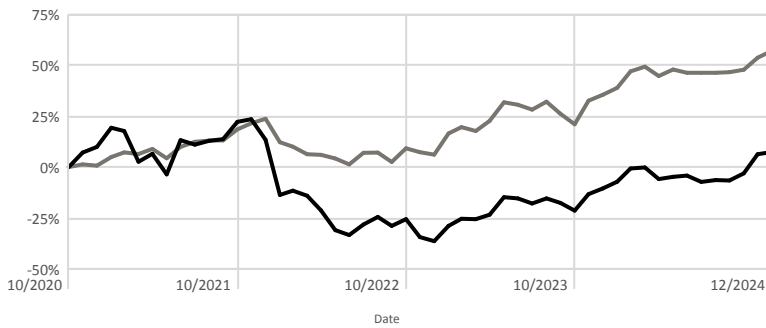
INVESTMENT OBJECTIVE

The AnBro BCI Unicorn Global Growth Fund aims to deliver high capital growth over the long term.

INVESTMENT POLICY

The Fund will invest in a diverse investment portfolio made up of quality growth companies which are mostly smaller by nature, have larger growth opportunities and long runways to grow at above average rates for many years, also known globally as “unicorns”. The portfolio’s equity as well as global exposure will be in excess of 80% of its net asset value. The portfolio’s investment universe will, apart from assets in liquid form, consist of equity securities, property securities, preference shares, non-equity securities, interest bearing securities and instruments. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

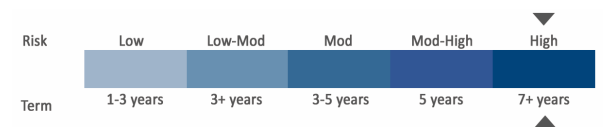
