INVESTMENT OBJECTIVE

The **Anchor BCI Diversified Stable Fund** is a multi-managed cautious risk profile portfolio with the objective being to provide investors with a high level of income and capital stability. This Fund is appropriate for clients who want exposure to Anchor's capabilities in a solution that is appropriately blended and diversified with other offerings to ensure a more consistent return profile.

INVESTMENT PHILOSOPHY

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. To provide a limited level of capital protection, the portfolio's equity may be as high as 40% of the portfolio's net asset value. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money-market instruments, interest-bearing securities, bonds, debentures, corporate debt, equity securities, other interest-bearing securities, property securities, preference shares, convertible equities and non-equity securities. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

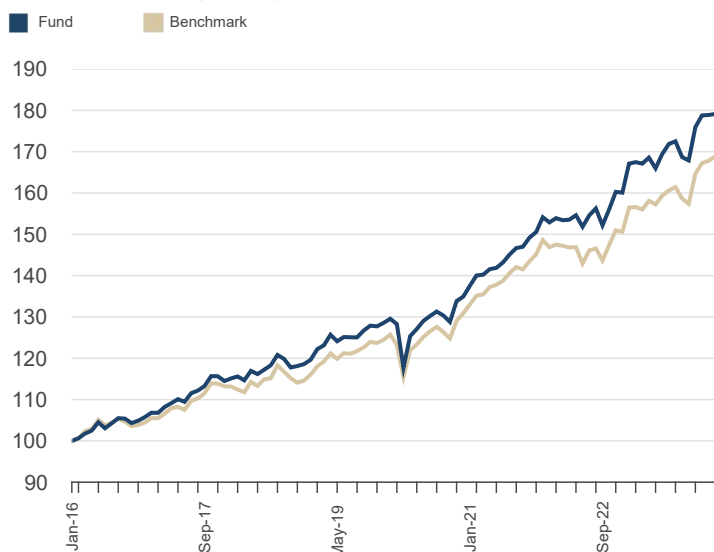

- The expected potential long term investment returns are lower over the medium to long term than higher risk portfolios.

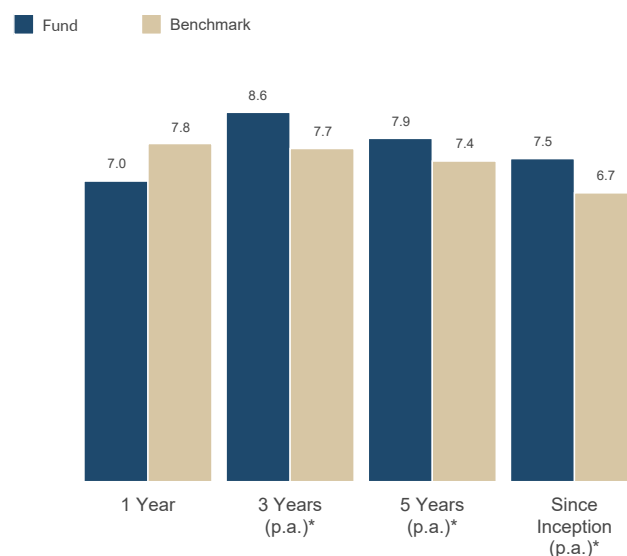
FUND PERFORMANCE SINCE INCEPTION

Growth of R100 investment (cumulative).



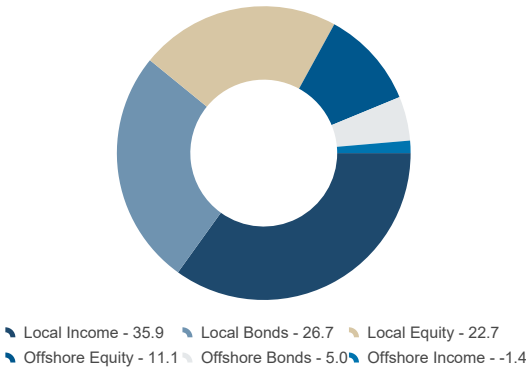

FUND MANAGER COMMENTARY AT 29 FEB 2024

During February, global financial markets navigated through a complex interplay of economic indicators, geopolitical tensions and central bank policies. In the US, ongoing concerns surrounding the US Federal Reserve's (Fed) monetary policy stance played a pivotal role. Investors closely monitored signals from the central bank regarding its approach to interest rates and inflation management amidst mounting pressures. Geopolitical tensions weighed on market sentiment, as escalating conflicts in certain regions raised concerns about the potential impact on global trade and economic stability. Moreover, developments in the technology sector continued to capture investors' attention, with advancements in areas such as artificial intelligence (AI), cybersecurity, and semiconductor manufacturing driving further optimism in this sector. As a result, both the S&P 500 and the Nasdaq 100 performed strongly over the month, increasing by 5.3% and 5.4% MoM, respectively. In local currency terms, the Euro STOXX 50 also had a strong month, ending up 5.0%, while the UK's FTSE 100 was little changed over the month, increasing by 0.5%, reflecting the weakness in mining and energy stocks. In Japan, equities were boosted by the Bank of Japan Governor Kazuo Ueda, expressing confidence that moderate inflation was likely to continue as wages grow, which resulted in the Nikkei 225 ending the month up a stellar 8.0%. On the domestic front, the FTSE JSE All Share underperformed its global counterparts, decreasing by 2.4%. The performance was predominantly impacted by the sell-off in the resources sector, which declined by 7.2% due to the poor performance from index heavyweights, Anglo American and Gold Fields, which declined by 7.1% and 9.4% MoM, respectively. The portfolio performed broadly in line with peers over the month. The performance was impacted by our overweight position to local bonds; however, this was negated to some extent by our overweight position to emerging market equities.
