INVESTMENT OBJECTIVE

The **Anchor BCI Equity Fund** is a general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT PHILOSOPHY

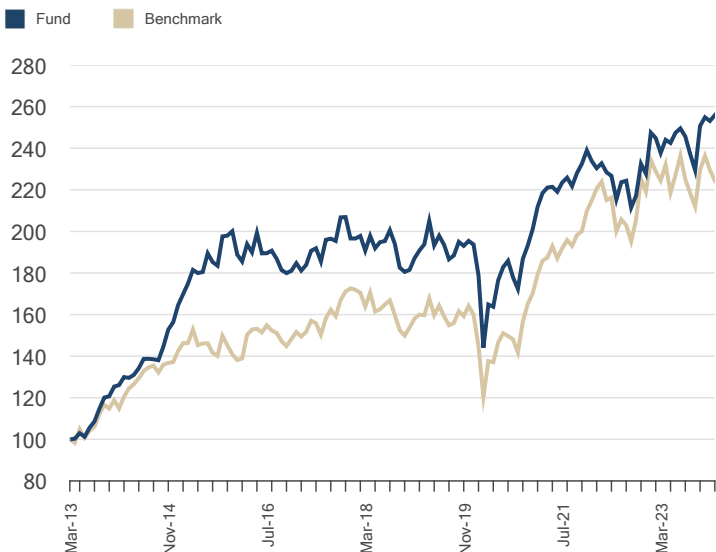
The portfolio is constructed from bottom-up, fundamental research with an investment philosophy that favours quality stocks with superior returns on capital, cash flows and pricing power. While acceptable valuation is an important component of the stock-selection process, the fund's style is not "value" - investments will be made in premium-rated stocks where the growth outlook and quality profile warrants it. The fund will also own shares that are often not well researched, yet offer exceptional valuation-driven opportunities. The quality of companies included is judged by rates of earnings growth, return on capital employed, cash conversion and stability of margins. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The manager may include the following unlisted financial instruments: forward currency, interest rate and exchange-rate swap transactions for efficient portfolio management purposes. The portfolio's equity exposure will always exceed 80% of the portfolio's net asset value.

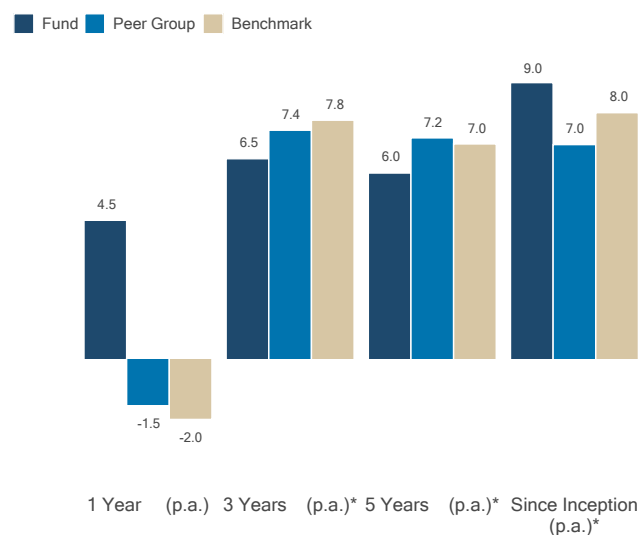

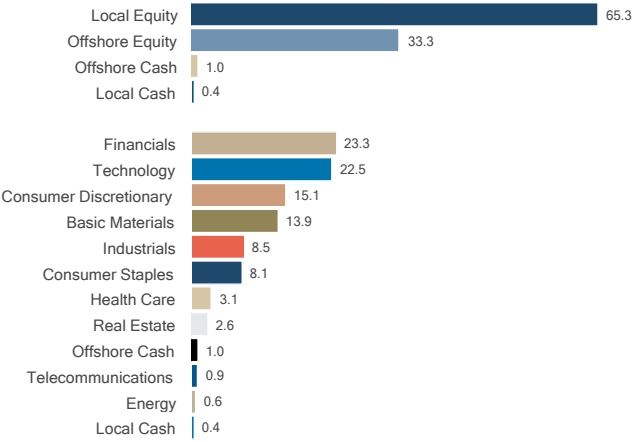
- This portfolio has a higher exposure to equities than any other risk profiled portfolio and therefore tends to carry higher volatility due to high exposure to equity markets.

FUND MANAGER COMMENTARY AT 29 FEB 2024

The Anchor BCI Equity Fund was up 1.1% in February, against the FTSE/JSE Capped Swix, which was down 2.3%. YTD, the fund is up 0.4% vs the benchmark, which is down 5.1%. With the JSE experiencing another tough month relative to global markets (MSCI World +7.7% in rand terms), the fund's exposure to high-quality offshore companies added the most to its relative performance for the month. The fund's positioning on the JSE benefited from the underweight positioning in the basic materials complex, particularly in the platinum group metals (PGMs) space, which experienced another difficult month on the back of the negative operating leverage we have become accustomed to in this PGM downcycle. Outside of the alpha generated in basic materials, the fund's underweight position in telcos (namely MTN) contributed nicely, as did the position in Transaction Capital, which has continued to recover after a disastrous 2023. The gains in the global portfolio were widespread, and it was good to see the portfolio keep up with a very narrow rally in technology and AI-related stocks via some good bottom-up calls in payments platform Adyen and luxury goods company Moncler. The fund remains defensively positioned in South Africa while offshore exposure to high-quality global franchises has been maintained.
