

**INVESTMENT OBJECTIVE**

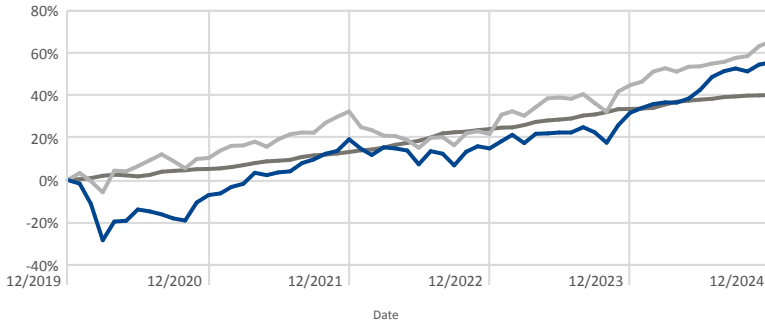
The aims to provide investors with moderate long term income and capital growth by investing in domestic and/or offshore asset classes.

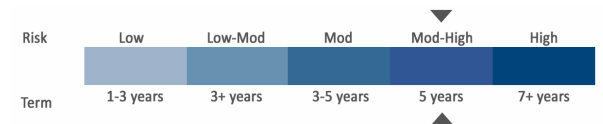

**Moderate - High Risk**
