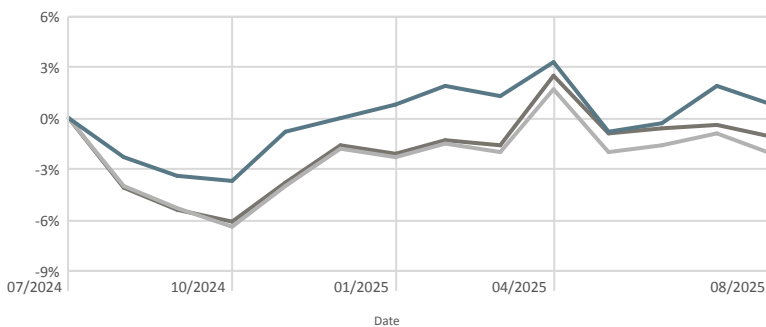
INVESTMENT OBJECTIVE

The Balondolozzi BCI Global Bond Fund aims to generate returns above a global bond index over time, utilising active bond management combined with strategies which aim to reduce risk.

INVESTMENT POLICY

The portfolio invests predominantly in global bonds. The portfolio's offshore exposure is greater than 80% of the portfolio's asset value. In order to achieve this objective, the investments normally to be included in the portfolio will comprise a combination of assets in liquid form and a combination of bonds and interest-bearing securities, including loan stock, debentures, debenture bonds, money market instruments, notes corporate debt and non-equity securities. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments.

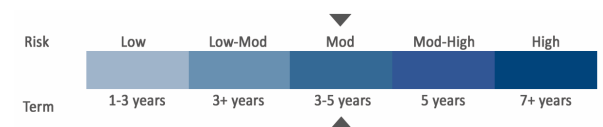

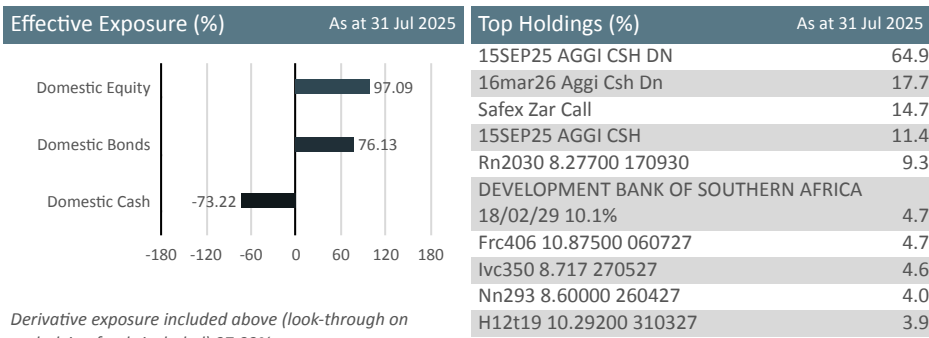


Moderate Risk
