

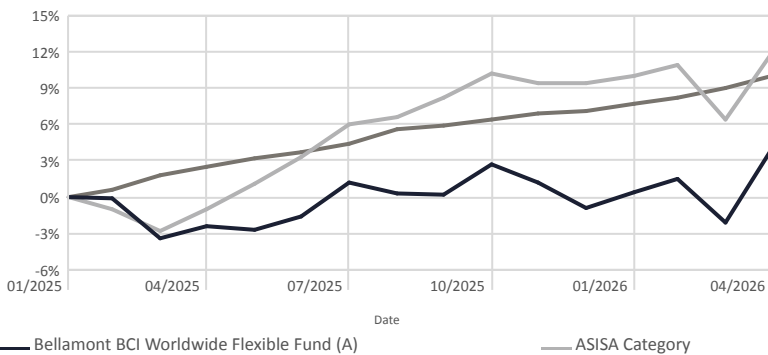
**INVESTMENT OBJECTIVE**

**INVESTMENT POLICY**

The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments.

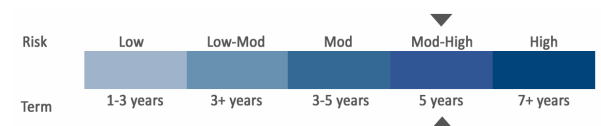

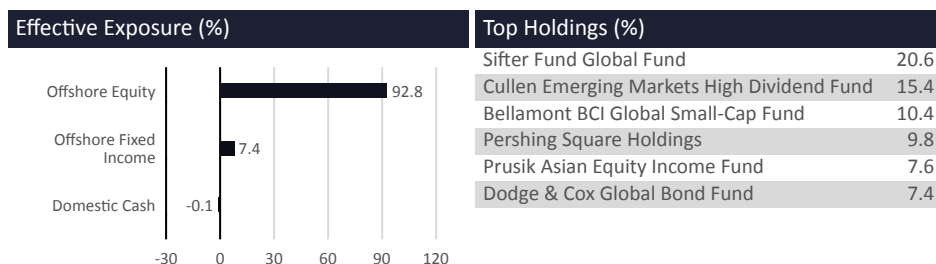
**Moderate - High Risk**
