

**INVESTMENT OBJECTIVE**

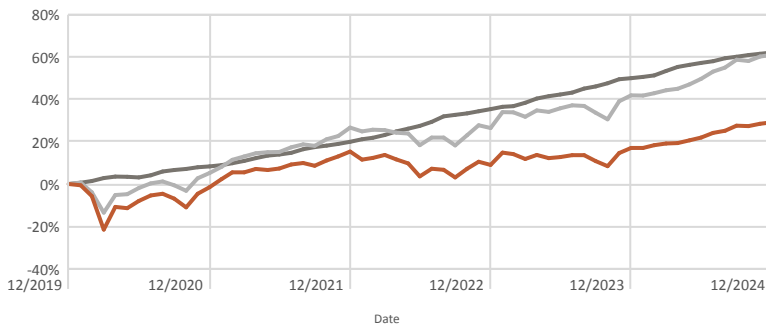
The Caleo BCI Balanced Fund of Funds is a multi-asset high equity portfolio with the objective to offer investors a moderate to high long term total return.

**INVESTMENT POLICY**

The portfolio's net equity exposure will range between 0% and 75% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

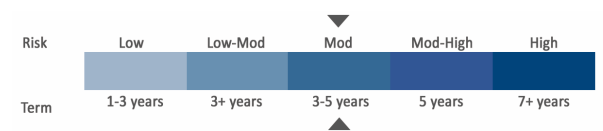

**Moderate Risk**
