

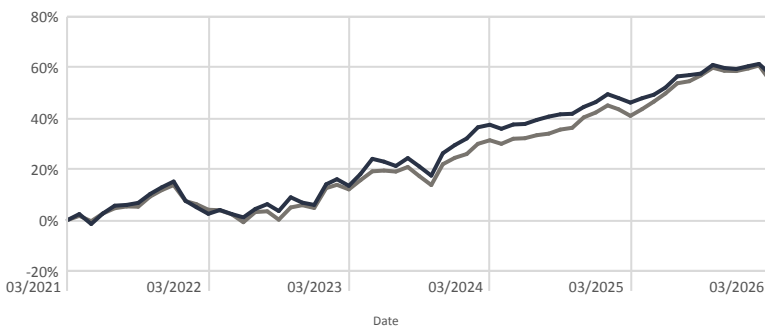
INVESTMENT OBJECTIVE

The Cedar Lane BCI Worldwide Flexible Fund is a worldwide flexible portfolio that aims to maximize long term capital growth.

INVESTMENT POLICY

The portfolio's offshore exposure and equity exposure may range between 0% and 100%. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities and instruments, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments

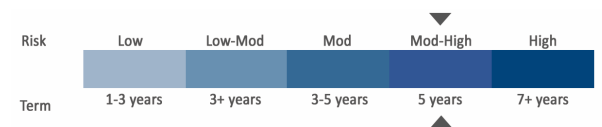

Moderate - High Risk
