INVESTMENT OBJECTIVE

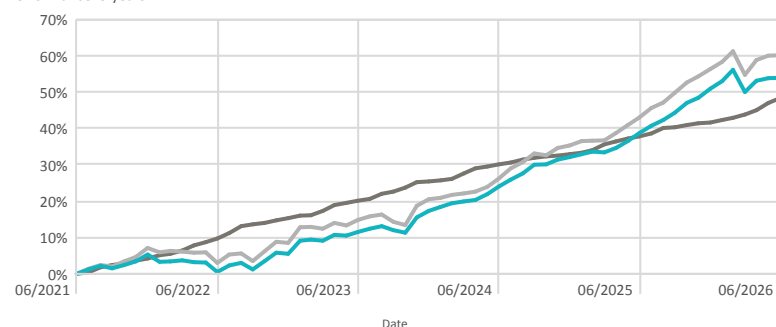
The primary investment objective of the portfolio is to provide the investor with a high level of income and stable capital growth.

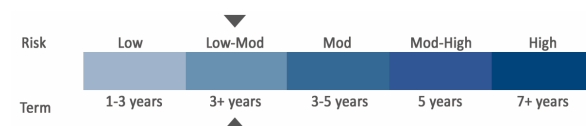
