



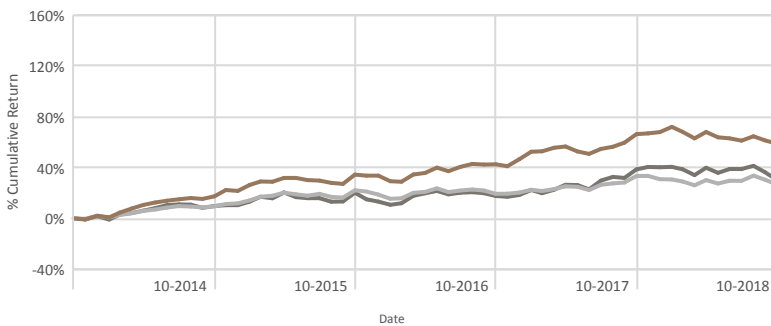
**INVESTMENT OBJECTIVE**

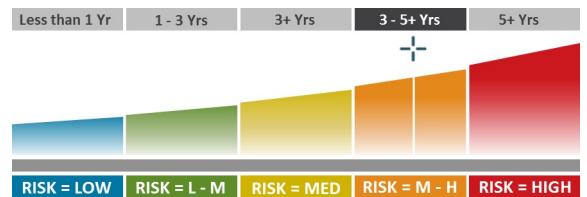

**Medium - High Risk**

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
