CITRINE BCI INCOME PROVIDER FUND (A)

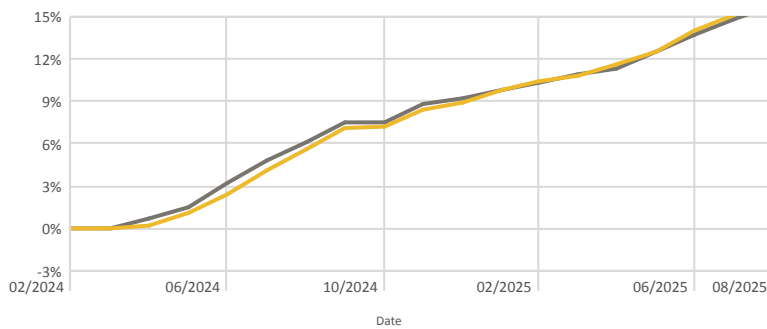
INVESTMENT OBJECTIVE

The Citrine BCI Income Provider Fund is an income generating portfolio with the objective of delivering a high level of sustainable income and stability of capital invested.

INVESTMENT POLICY

Investments to be acquired for the portfolio may include equity securities, property securities, property related securities, interest bearing securities and instruments, non-equity securities, bonds, money market instruments, preference shares, notes and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes, registered in South Africa and other similar schemes operated in territories with a regulatory environment. The portfolio may from time to time invest in listed and unlisted financial instruments. The portfolio's equity exposure not exceeding 40% of the portfolio's net asset value.

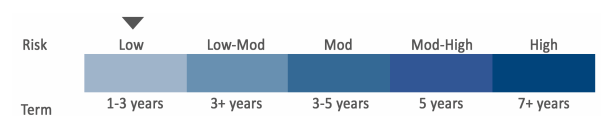
