

INVESTMENT OBJECTIVE

The Citrine BCI SA Bond Fund aims to generate returns above the FTSE JSE All Bond Index (“ALBI”) over time, utilising active bond management combined with strategies which aim to reduce risk.

INVESTMENT POLICY

In order to achieve this objective, the investments normally to be included in the portfolio will comprise a combination of assets in liquid form and a combination of bonds and interest-bearing securities, including loan stock, debentures, debenture bonds, money market instruments, notes, corporate debt and non-equity securities. The portfolio may also invest in participatory interests or any other form of participation in portfolios of South African collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio’s investment policy. The portfolio invests predominantly in domestic bonds. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio’s investment objective.

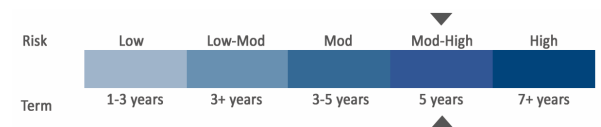

RISK PROFILE



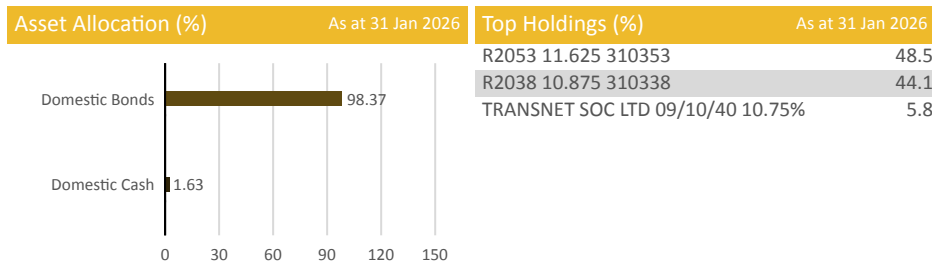
Low - Moderate Risk
