

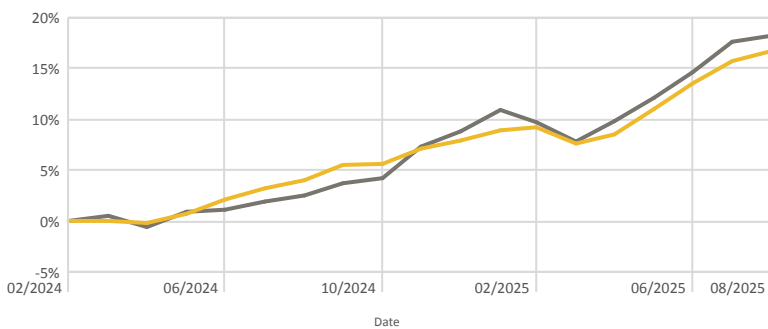
INVESTMENT OBJECTIVE

INVESTMENT POLICY

The portfolio has investment instrument exposure across multiple asset classes and countries. Investments included in the portfolio consist, apart from assets in liquid form, of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

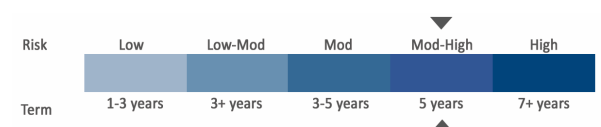

RISK PROFILE



Moderate - High Risk

- Therefore, it is suitable for medium to long-term investment horizons.

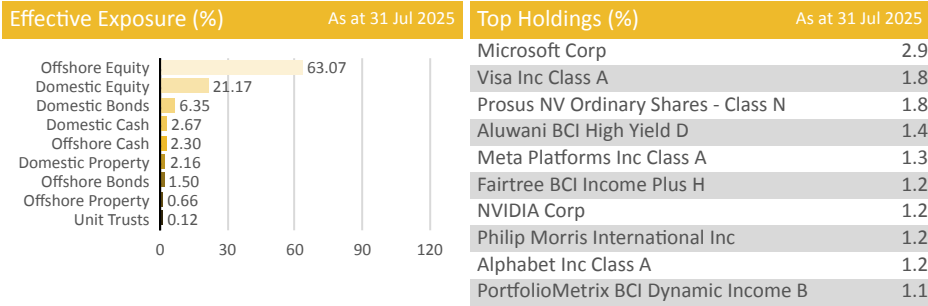
