

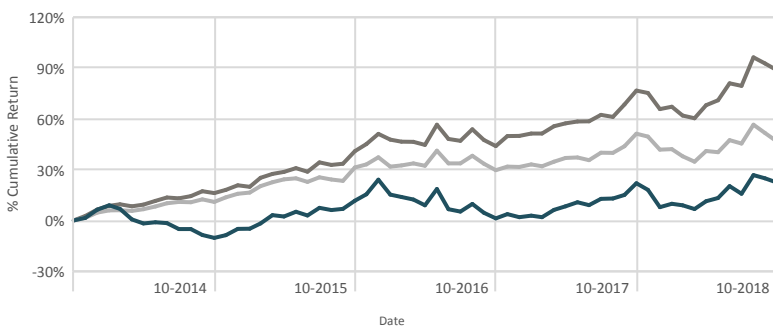
### INVESTMENT OBJECTIVE

The Consilium BCI Worldwide Flexible Fund is a worldwide flexible portfolio that aims to provide investors with long term total capital returns.

### INVESTMENT UNIVERSE

The portfolio may invest in financially sound global and local equity securities, government -, corporate- and inflation linked bonds, debentures, non-equity securities, property shares, property related securities, preference shares, money market instruments and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions.

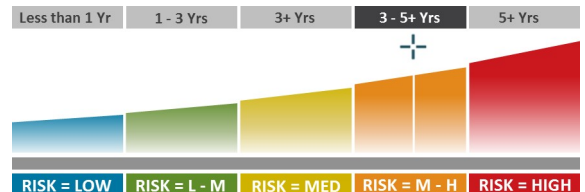

#### Medium - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
