

INVESTMENT OBJECTIVE

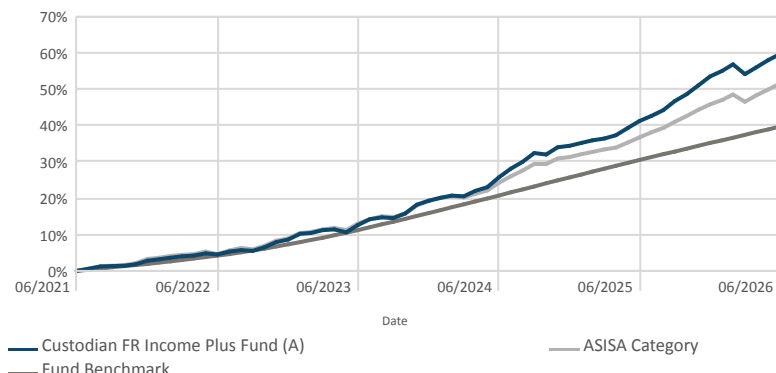
The Custodian FR Income Plus Fund is a specialist income generating portfolio. The investment objective of the portfolio is to achieve a high level of sustainable income and stability of capital invested. Protection strategies may be implemented to reduce risk and volatility.

INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. However, the portfolio's equity exposure may be as high as 10% of the portfolio's net asset value. The portfolio may from time to time invest in listed and unlisted financial instrument. The manager may only include the following unlisted financial instruments: forward currency, interest rate and exchange rate swap transactions.

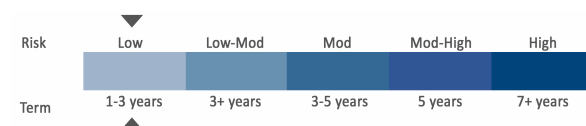
