

**INVESTMENT OBJECTIVE**

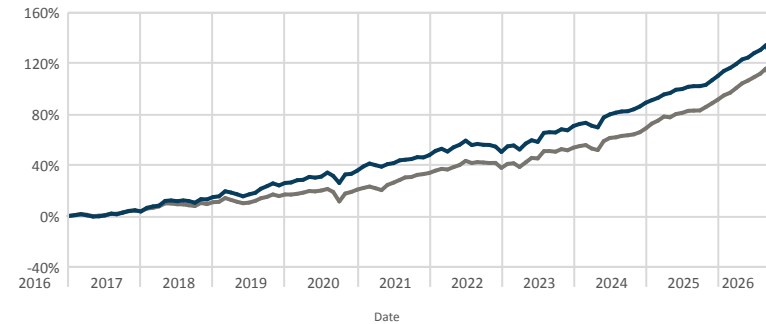
The Financial Fitness BCI Stable Fund of Funds aims to deliver a high level of income combined with long-term capital stability.

**INVESTMENT POLICY**

Investments included in the portfolio consist, apart from assets in liquid form, of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes. The investments will be in consistent with the portfolio's primary objective investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities. The portfolio's equity exposure will be a maximum of 40% of the portfolio's net asset value. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

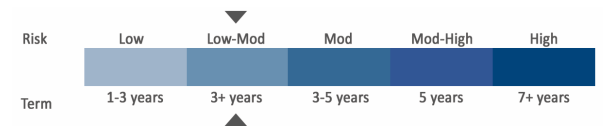
