

INVESTMENT OBJECTIVE

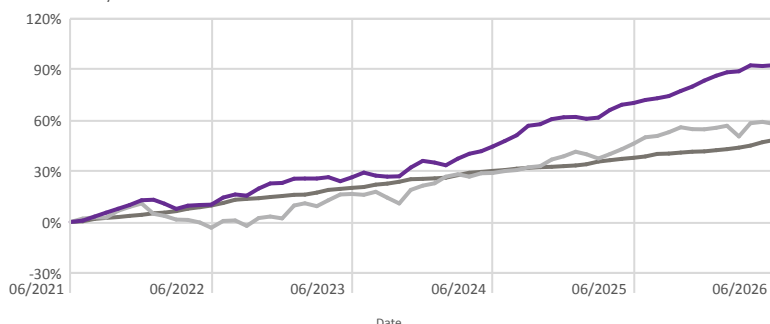
The Flagship FR Prosperity Worldwide Flexible Fund of Funds is a moderate risk profile portfolio that aims to provide investors with medium to long term wealth prosperity.

INVESTMENT POLICY

The portfolio is managed within the following asset class maximum exposure limits: 90% equity, 80% foreign, 50% bonds and 25% property. Investments included in the portfolio consist, apart from assets in liquid form, of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

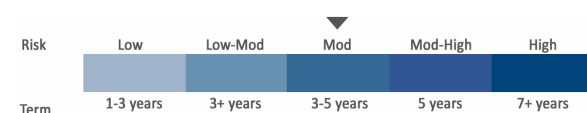

Moderate Risk

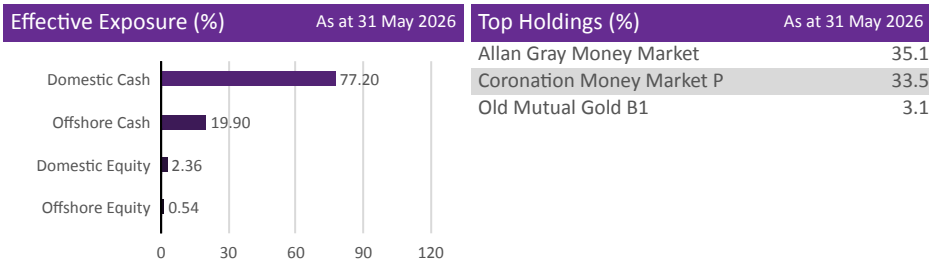
