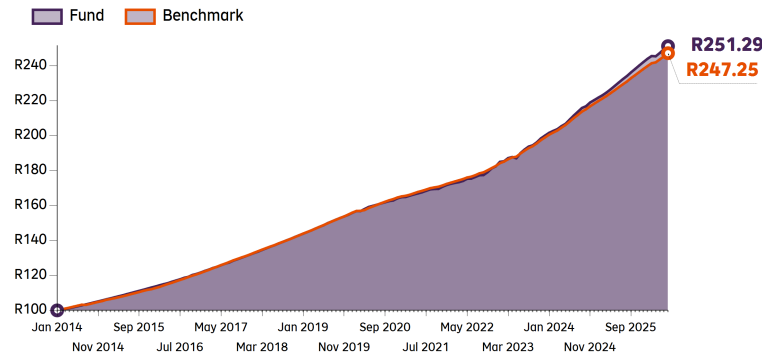

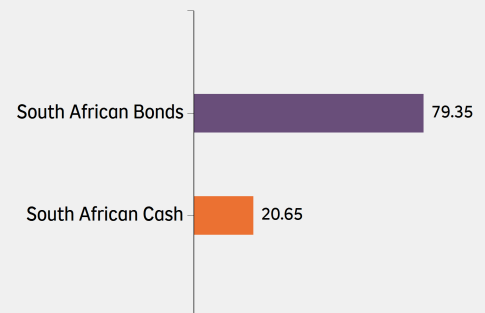

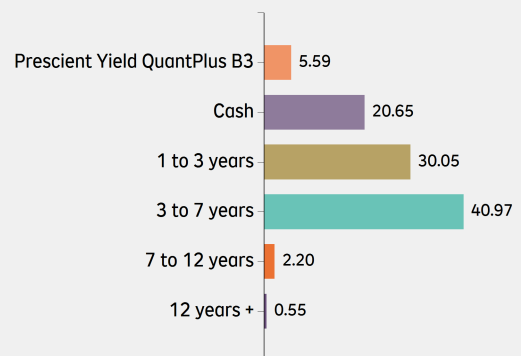

Sector & Maturity Exposure (%)



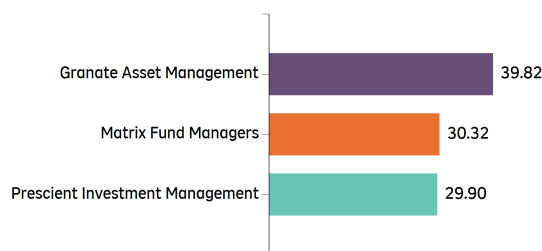
