

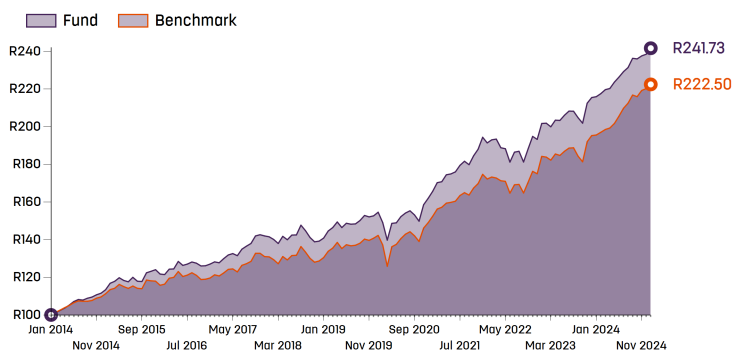

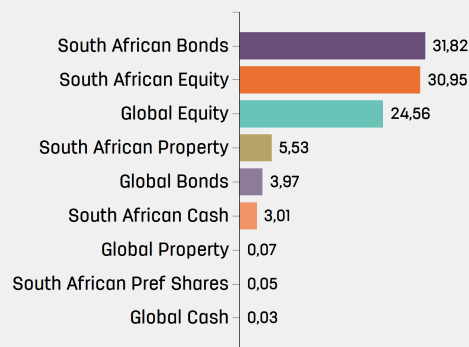

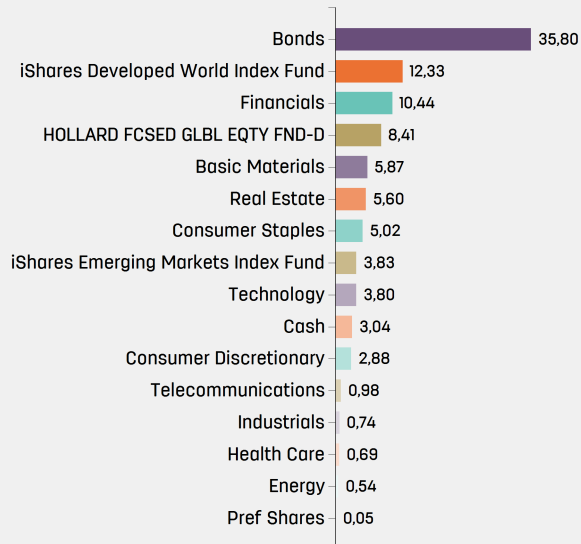

Sector Allocation (%)



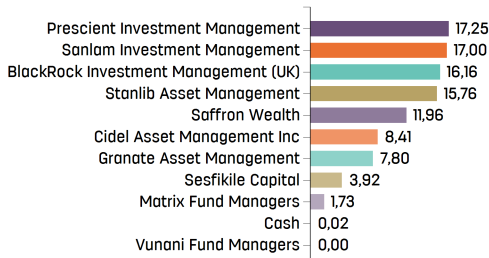

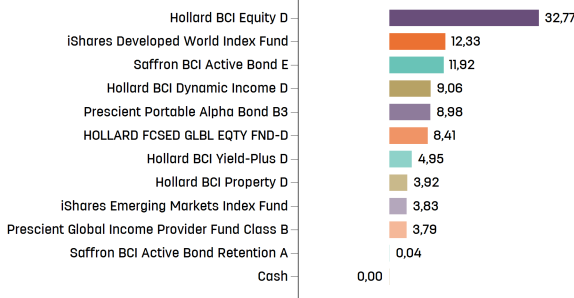
